PICKUP LOCATION AND OFFICE HOURS

Sea Pines Community Services Associates 175 Greenwood Drive, Hilton Head Island, SC 29928 Weekdays from 7:30am to 4:30pm. (Excluding weekends, holidays)

The CSA office is located inside Sea Pines and a gate pass is required to pickup your decal. Bring the pass with you to the office for a refund. Only same-day gate passes can be refunded.

Check, cash, and major credit cards* are accepted for payment at the time of pickup. Make checks payable to "CSA Security".

*A 2.95% convenience fee will be added to all credit card transactions.

ANNUAL DECAL APPLICATIONS MUST BE ACCOMPANIED BY THE CURRENT VEHICLE REGISTRATION.

Commercial companies may present a temporary vehicle registration to receive a temporary pass. Decals will only be issued with permanent registration/license plate information.

Employee rosters and other applicable documentation should be emailed to SecurityAdmin@CsaSeaPines.com.

DECAL REPLACEMENTS

Replacement decals must be requested online and only for the calendar year issued. The original decal must be removed from the vehicle (even if in pieces) and returned to obtain a replacement decal. Decals are not transferable. A \$6 fee applies for any decal replacements. A new decal will need to be purchased if the original decal cannot be returned. Commercial hangtags are not replaceable even if lost or stolen.

All decal applications must include a valid, permanent vehicle registration. Decals are non-transferable and must be permanently affixed to the assigned vehicle.

All requests for replacement decals during the year must be accompanied by an application, the original decal, and a \$6 fee (when applicable).



EMPLOYEE DECAL

Full-time employees of businesses located within Sea Pines. The business shall provide a list of full-time employees to Sea Pines CSA via email: securityadmin@csaseapines.com. The vehicle must be registered in South Carolina or Chatham County, Georgia and registered to the employee.

The first decal is free. Each additional decal is \$6.

ISLAND RESIDENT PREFERRED PASS (PELICAN PASS)

Documented Hilton Head Island residential property owners. Beach access is not permitted.

\$50 per vehicle. (\$25 after July 1st)

RELATIVE DECAL

Immediate family members of Sea Pines property owners (son, daughter, mother, father, grandson, granddaughter, grandfather, grandmother, sister, brother) and with written property owner approval sent to securityadmin@csaseapines.com.

\$6 (One decal per relative, per year is permitted)
Tower beach access is not permitted.

NON-RESIDENT DECAL

Residents in Beaufort and Jasper counties in South Carolina, Chatham County, Georgia, or renting on Hilton Head Island. \$125 per vehicle. (\$63 after July 1st).

LONG TERM RENTER DECAL

Long-term renters within Sea Pines with a lease agreement lasting six months or more.

\$25 each vehicle, Limit of 4 decals. (\$13 after July 1st).

HILTON HEAD PREP DECAL

Eligible students at Hilton Head Preparatory School within Sea Pines. Access through the Ocean Gate only during school hours. The first decal is free. Each additional decal is \$6.
