

# CSA Finance Committee Meeting Minutes Tuesday, January 17, 2017 CSA Main Conference Room

## 2. Introductions

Mr. Borghesi introduced Mr. John McEnery to the group. Mr. McEnery will be joining the Finance Committee. Mr. Borghesi also noted this was Mr. Marsac's last meeting and thanked him for his six years on the Committee.

# 3. Approval of the November 21, 2016 Meeting Minutes

A copy of the November 21, 2016 meeting minutes was included in the committee's package and reviewed. Mr. Warco made the following motion, seconded by Mr. McCollum and unanimously passed:

## 4. Acceptance of Unaudited YTD Financial Statements

A copy of the October financial statements were included in the committee's package and reviewed. Ms. Laudermilch made the following motion, seconded by Ms. Adams and unanimously passed:

"RESOLVED, the Finance Committee recommends the Board of Directors accept the October 2016 YTD financial statements as presented."

### 5. New Business

- a. Status of Financial Impact on CSA of Hurricane Matthew- Ms. Shanahan and Mr. Martin discussed the costs associated with Hurricane Matthew through December which is in excess of \$2.2 million. Recovery costs are still being incurred and Mr. Barnett is working on a revised forecast of anticipated costs for 2017.
- b. Currently Liquidity Position As of December 31, 2016 CSA had borrowed \$1.5 million from the Morgan Stanley line of credit. The entire balance was repaid in January through annual and special assessment receipts.
- c. GAAP Accounting for Hurricane Matthew Mr. Borghesi presented an email from Ed Royall of Elliott Davis Decosimo regarding the proper accounting for revenues and expenses related to Hurricane Matthew. There was general agreement to the suggested GAAP reporting for year-end financial statements.
- d. Status of Hurricane Matthew Insurance Claim Mr. Borghesi discussed that an insurance claim was filed for time element losses related to Hurricane Matthew. The claim is under review by the insurance carrier.
- e. **Reserve Study Workshop** A Reserve Study Workshop was held on Monday, January 16, 2017 and was attended by many of the members of the Finance Committee. Based upon discussions during the Workshop, Borghesi and Shanahan presented a draft analysis and funding policy. The consensus of the Finance Committee was to accept both the analysis and policy pending discussions with CSA Class B Board members.
- f. **2017 Finance Committee Meeting Schedule** There are six meeting schedule for 2017. It was discussed there may be a need for an additional meeting before the schedule March 21, 2017 meeting.

#### 6. Adjournment

With no further business to conduct Ms. Adams made a motion to adjourn the meeting at 10:100 a.m. seconded by Mr. Farrenkopf.
