Call to Order

David Ellis, Chair, called the meeting to order at 9:30 a.m., Eastern time.

Establishment of Quorum

With a majority of Board Members in attendance, quorum was established.

Call to Executive Session

Approval – Possible Actions Related to Executive Session

Sea Pines CSA Board of Directors meeting reconvened at 10:00 a.m. No actions were taken.

Ratify Approval – Sea Pines CSA Board of Directors Meeting Minutes, February 21, 2023

A motion was made by Lee Ann Leahy, to support the resolution, "Ratify Approval – Sea Pines CSA Board of Directors Meeting Minutes, February 21, 2023". The motion was seconded and unanimously carried:

Chair Remarks – Chair Ellis

- o Daily gate pass sales, increased. Gate traffic solutions, ongoing;
- o Cross Island Parkway toll, removed. Traffic entering Sea Pines Circle, increased. Town of Hilton Head Island aware, committed to solution;
- Neighborhood disturbances, i.e., noise, blowers, maintenance work, exist. A more dramatic approach, difficult to implement at this time, to be necessary to address such issues;
- o All Property Owner emails received, are read, if not responded to, by Chair and Staff. All comments taken under consideration;
- Ebikes Task Force, Walkers Advisory Group, to be created. Group to consist of leisure path walkers. All interested parties to email Chair. First ten Property Owners to respond will be assigned to Ebikes Task Force, Walkers Advisory Group;
- Ebikes currently banned in Sea Pines. Ban to remain in place during attorney and insurance carriers review;
- Critical Infrastructure Referendum, Federal case, on appeal. Plaintiff Appellate Brief filed. Sea Pines CSA to file response, within next forty-five days, as Court dictates. Court to advise next steps;
- Over 1700 new Sea Pines Property Owners in past two years. Many confused as to \$600 Critical Infrastructure Assessment, 2022 and Sea Pines yearly assessments.
 Communication to continue to Property Owners;
- Tickets to top tier event, RBC Heritage, Presented by Boeing, Golf Tournament, April 10

 16, 2023, sold out.

President Remarks – Sam Bennett

- Meetings with Town of Hilton Head officials, Marc Orlando/Town Manager and Bob Bromage/Public Safety Director, successful. Town aware and committed to resolving Sea Pines Circle challenges. Traffic management project underway, to include Smart Signalization Program;
- o RBC Heritage Golf Tournament upcoming. Sea Pines CSA maintains close relationship with Heritage Classic Foundation and the Sea Pines Resort. Steve Wilmot/President, Tournament Director, Heritage Classic Foundation, to send letter to the community;
- Sea Pines CSA Director of Security and Safety position, vacant. Numerous resumes received. Interviews to commence in coming weeks;
- o Control burn, part of the Sea Pines Forest Preserve Management Plan, underway.

Management Reports

Sea Pines CSA Management provided updates on their respective departments: Community Infrastructure, Mr. Fredericks; Community Maintenance and Standards, Mr. Mayse; Communications, Mrs. Sutcliffe-Jones; Finance and Administration, Ms. Shanahan; Operations and Special Projects, Ms. Shanahan and Safety, Security and Transportation, Mr. Bennett.

Committee recommendations brought to Sea Pines CSA Board of Directors for approval, included: Finance Committee, Mrs. Leahy, Chair. Refer to Financial Report, Approval – Amendment to Budget, 2023.

Financial Report – Victoria Shanahan

- o Financial Statements, YTD/December 31, 2022, currently under audit;
- o Balance Sheet and Income Statement, reviewed;
- Year end 2022, finished with positive \$1.2M;
- Budgeted, unused 2022 Major Repairs and Replacements funds, to be rolled over into amended Budget, 2023;
- o Critical Infrastructure Assessment, 2022, currently at 527, uncollected;
- o Sea Pines Assessment, 2023, due April 1, 2023;
- o Implementation of Sea Pines Rental Registration Program, in process. Short term, long term and timeshare rentals, to be included. To date, Sea Pines CSA "R Program" indicated 2,382 rentals, including timeshares. Fees to be based on number of bedrooms advertised. Ability to cross reference against Town of Hilton Head's rental list, once finalized. Details to be communicated as available.
- o To date, daily visitor gate passes up 22%, year over year.

<u>Approval – Amendment to Budget, 2023:</u>

A motion was made by Lee Ann Leahy, to support the resolution, "Approval – Amendment to Budget, 2023". The motion was seconded and unanimously carried:
