# Acceptance – Financial Statements, YTD/March 31, 2023

The balance sheet as of YTD/March 31, 2023 was reviewed. Total liabilities and fund balances, on an accrual basis, were \$30,874,430, as compared to prior year, of \$23,883,994. The income statement as of YTD/March 31, 2023, was reviewed. Actual revenues over expenditures were \$9,462,901, as compared to budget and prior year actual, of \$6,076,487 and \$5,164,468, respectively.

A motion was made by Larry Movshin, to support the resolution, "Acceptance – Financial Statements, YTD/March 31, 2023". The motion was seconded and unanimously carried:

## Acceptance – Financial Statements, YE/December 31, 2022, Audited

The balance sheet as of YE/December 31, 2022 was reviewed. Total liabilities and fund balances, on an accrual basis, were \$22,820,495, as compared to prior year, of \$20,961,212.

The income statement as of YE/December 31, 2022, was reviewed. Actual revenues over expenditures were \$1,261,700, as compared to prior year actual, of (\$1,057,897).

A motion was made by Lee Ann Leahy, to support the resolution, "Acceptance – Financial Statements, YTD/December 31, 2022, Audited". The motion was seconded and unanimously carried:

- o On May 4, 2023, the Audit Subcommittee of the CSA Finance Committee met with the external auditors and financial management;
- O CSA received the communications that the Board is required to obtain from the auditors. The audit partner, Cindy Brams, was very complimentary of the preparation of the financial statements and the work for the audit. No adjustments, no disagreements, no material weaknesses or significant deficiencies in internal controls were noted. No adjustments were made to the financial statements either;
- The Audit Subcommittee agreed to accept the report of the external auditors and the audit results and report to the Executive Committee and Finance Committee on May 9, 2023 and to the full Board on May 16, 2023.
