<u>Acceptance – Financial Statements, YTD/August 31 31, 2023</u> – Victoria Shanahan The balance sheet as of YTD/August 31, 2023 was reviewed. Total liabilities and fund balances, on an accrual basis, were \$27,675,963, as compared to prior year, of \$20,695,891.

The income statement as of YTD/August 31, 2023, was reviewed. Actual revenues over expenditures were \$7,488,032, as compared to budget and prior year actual, of \$3,443,491 and \$2,024,924, respectively.
