Financial Report – Victoria Shanahan

- o Recap of YTD/September 30, 2022, Financial Statements, provided;
- o Balance Sheet and Income Statement, reviewed.

Acceptance – Financial Statements, YTD/September 30, 2022

The balance sheet as of YTD/September 30, 2022 was reviewed. Total liabilities and fund balances, on an accrual basis, were \$20,095,864, as compared to prior year, of \$22,015,599.

The income statement as of YTD/September 30, 2022, was reviewed. Actual revenues over expenditures were \$1,434,812, as compared to budget and prior year actual, of (\$3,769,831) and \$2,225,453, respectively.

<u>Approval – Adoption, Auditor, Sea Pines CSA Financial Statements YE/2022</u>
A motion was made by Chair Movshin, to support the resolution, "Approval – Adoption, Auditor, Sea Pines CSA Financial Statements YE/2022". The motion was seconded and unanimously carried:

"**RESOLVED**, Sea Pines Community Services Associates, Inc., Board of Directors, approved adoption of Elliott Davis, LLC, as Auditor, for Sea Pines CSA's Financial Statements YE/December 31, 2022".

Approval – Assessment, 2023, Residential Property Owner

A motion was made by Chair Movshin, to support the resolution, "Approval – Assessment, 2023, Residential Property Owner". The motion was seconded and unanimously carried:

"RESOLVED, Sea Pines Community Services Associates, Inc., Board of Directors, approves an increase over the 2022 Assessment, bringing the 2023 Residential Property Owners Annual Assessment, on an improved lot, from \$1,752 to \$1,887 (\$600 and \$647, respectively, represent the Critical Infrastructure portion of the Assessment) and the 2023 Residential Property Owners Annual Assessment, on an unimproved lot, from \$1,046 to \$1,127 (\$360 and \$388, respectively, represent the Critical Infrastructure portion of the Assessment)".

Approval – Budget, 2023

A motion was made by Chair Movshin, to support the resolution, "Approval – Budget, 2023". The motion was seconded and unanimously carried:

"**RESOLVED**, Sea Pines Community Services Associates, Inc., Board of Directors, approved Budget, 2023, as presented".
