## Financial Report - Victoria Shanahan

### Acceptance – Financial Statements, YTD/August 31, 2021

The balance sheet as of YTD/August 31, 2021 was reviewed. Total liabilities and fund balances, on an accrual basis, were \$22,710,202, as compared to prior year, of \$22,469,585.

The income statement as of YTD/August 31, 2021, was reviewed. Actual revenues over expenditures were \$2,973,843, as compared to budget and prior year actual, of \$274,911 and \$3,787,887, respectively.
