Call to Order

David Ellis, Chair, called the meeting to order at 9:30 a.m., Eastern time.

- Board of Directors, 2023, experienced large turnover in membership. Retired from Board were: Carolyn Adams, Dave Borghesi, Mark King and Rich Speer. Positions filled by: Ray Warco, Lee Ann Leahy, Rick Ray and Ann Esposito, respectively;
- Sea Pines Covenants dictate membership of the Board of Directors be comprised of: 9
 Residential Property Owners (elected), 4 Commercial Property Owners (elected) and 4
 Resort Appointees (appointed);
- o Mrs. Leahy, Mrs. Esposito and Mr. Warco were welcomed to the Board and each provided brief background statements. Chair Ellis provided statement from Mr. Ray;
- o Mr. Movshin thanked for his leadership as Chair the last several years, in particular the success in securing the process to fund critical infrastructure;
- o Several Committees found to be overlapping and restructure is underway;
- o As appropriate, Community feedback and participation in issue solving, to be sought;
- o Community feedback regarding e-bikes resulted in excess of 500 comments. Community is very divided. Task Force, to include Residential Property Owners, to be initiated.

President Remarks – Sam Bennett

- Thanks and appreciation extended to Mr. Movshin for his years of service and leadership, as Chair;
- o Director of Safety, Security and Transportation, Toby McSwain, tendered resignation;
- o Captain Coleman, assuming department responsibilities, until Chief of Security secured;
- o RBC Heritage Golf tournament, second week of April, has comprehensive tournament operation plan, in place;
- o Plantation Drive waterline/repaving and Braddock Creek/Harbour Town dredging, both currently underway, are not Sea Pines CSA projects.

Management Reports

Sea Pines CSA Department Heads provided updates on their respective departments: Community Infrastructure, Mr. Fredericks; Community Maintenance and Standards, Mr. Mayse; Communications, Mrs. Sutcliffe-Jones; Finance and Administration, Ms. Shanahan; Operations and Special Projects, Mr. Henderson and Safety, Security and Transportation, Mr. Bennett.

Financial Report – Victoria Shanahan

- O YE financial statements not available, pending audit;
- o 2022 ended with \$1.2M positive fund balance, attributable to \$3.9M critical infrastructure billing, not available in the past. Approximately \$3.1M of the critical infrastructure revenue spent to date. Critical Infrastructure fund balance positive, \$1M+;
- o \$3.6M in major projects and repairs spent this year;
- Budget, 2023, to be amended to reflect unspent funds from budgeted projects not completed in 2022.
